ITEM 3 GENERAL ANNOUNCEMENTS (taken out of order)

Chair Hewlett congratulated the Montgomery County Planning Department for receiving the State's Sustainability Growth Commission Award for the implementation of the White Flint Sector Plan. Chair Hewlett also praised staff for efforts in promoting and coordinating the wonderful Black History Month programs in Montgomery County and Prince George's County. Commissioner Bailey also thanked staff for making the program a success and recognizing and incorporating the theme. As a member of the Association for the Study of African American Life and History, she had an opportunity to honor Black History month at the White House, and reminded the President and the White House staff that there is a theme every year for Black History Month. Ms. Bailey also shared her recent experience meeting Ms. Joan Mulholland a speaker at one of the Prince George's County Black History programs. Commissioner Bailey explained that Ms. Mulholland is a Southern

civil rights advocate. During a panel discussion at one of the Prince George's County's Black History programs they discovered that they had both marched together in Durham, North Carolina, in the civil rights movement. Commissioner Bailey shared information on some historical moments with the audience. She noted that Ms. Mulholland's son has written a documentary about his mother's life, entitled, "An Ordinary Hero," and encouraged the group to read the book.

Chair Hewlett mentioned additional programs that will be presented, including an exhibit of the African Americans in the Military Fighting on Two Fronts, at the Montpelier Cultural Arts Center.

Vice-Chair Carrier announced that Montgomery County's final Black History Month event this year is planned for February 22<sup>nd</sup>, will feature performers Esther Williams and Shirletta Settles, native Washingtonian women who will share music and stories around the theme of "Changing America, the Emancipation Proclamation."

Chair Hewlett also announced the Commission's celebration of the Women's History Month on March 11<sup>th</sup>, at 11:30 a.m., at Brookside Gardens. Chair Hewlett encouraged early registration due to limited capacity. Chair Hewlett recognized the leadership and guidance of Commissioner Mary Wells-Harley for initiating the celebration.

Chair Hewlett congratulated Commissioner Washington, in absentia, on her recent appointment as the President and the Chief Executive Officer of the Congressional Black Caucus Foundation.

#### ITEM 5 <u>a) RECOGNITION OF DIVERSITY COUNCIL MEMBERS AND PHOTO</u> <u>WITH COMMISSIONERS</u>

Chair Hewlett complimented the 2011 – 2012 Diversity Council on their excellent work and announced that the 2013 Council has been formed. Executive Director Barney shared background on the Diversity Council, including its purpose to ensure that employees understand the importance of respecting differences and working together productively. The Council focuses on inclusion and diversity, which is a part of the agency's business model. She commented that the new Diversity Council reflects a cross section of employees representing additional diversity in positions, experience,

gender, and ethnicity. She thanked the Department Directors for their outreach efforts in locating new members

The Executive Director recognized departing Diversity Council members for their service and commitment, and acknowledged members of the 2013 Council, including those who were serving out their second term. #### b) PRACTICE 3-31 - FRAUD, WASTE, AND ABUSE

Corporate Policy and Management Operations Division Chief, Anju Bennett presented final proposed amendments to Administrative Practice 3-31, Fraud, Waste, and Abuse. She stated that staff was seeking approval of these additional amendments, along with those presented at the Commission meeting on January 16<sup>th</sup>. The newer amendments were highlighted to assist Commissioners in their review. These amendments resulted from additional review of a few areas identified during the initial presentation of the policy on the January 16th. Ms. Bennett indicated that the changes were supported by the Executive Committee which reviewed the changes with staff earlier in the month. Changes were provided in the attachment, Item 5b.

The Commissioners supported the amendments. Commissioner Geraldo recommended that line 38 on page 5 be amended to read, "Any individual **who has engaged** in fraud, waste, or abuse."

A. The Northern Trust Company Presentation by Harland Abraham, Vice President

i. A Relationship Review

MR. ARDISON arrived at 10:09 a.m.

MR. JONES arrived at 10:11 a.m.

Mr. Harland Abraham, Vice President and Relationship Manager from the ERS' custodian bank the Northern Trust Company, presented a review of the comprehensive suite of services provided as part of Northern Trust's global custody service which includes, but is not limited to benefits payments, protecting the ERS' assets, income collection and tax reclamation, assisting with receipt of class action settlement proceeds, proxy voting, and accounting and reporting.

**B.** Earnest Partners

Presentations by Paul E. Viera, CEO and Partner and Yuca Xiuhua Gu, CFA, FRM – Investment Management Team

i. Access to the China A-Share Market

Mr. Paul Viera presented the Earnest Partners China Fund. This fund is an opportunity to access the domestic securities market of China, also known as the A-Share market. Earnest Partners' believes the Chinese stock market represents tremendous potential investment opportunities. China's A-Share market is the second largest in the world, with a capitalization of over \$4 trillion USD, over 2,000 listed companies and 73 million investors.

Mr. Viera said accessing the A-Share market means accessing the potential future growth of China, as well as a much more diversified list of industries whose companies are not listed outside of China. The current environment also creates an opportunity to get into the A-share market at relatively attractive valuation levels.

A-Shares trade on the Shenzhen and Shanghai Stock Exchanges. The market was previously closed to foreign investors until 2002, when foreign investments were allowed through the Qualified Foreign Institutional Investor (QFII) system. Obtaining a QFII license involves a rigorous due diligence process by various regulatory bodies in China. The QFII license is a limited opportunity available to only a few select investors globally.

EARNEST Partners has recently obtained their QFII license and has created the EARNEST Partners China Fund. Due to certain Chinese securities rules, all the operational details will combine with the existing International Strategy portfolio as a conduit; although nominally a commingled vehicle. The China Fund will be managed by the same investment team and research process. There are no additional fees to the ERS. Mr. Viera indicated that Earnest Partners would like the ability to invest in the A-Share market via the China Fund on behalf of the ERS. The Board's Investment Consultant, Wilshire's Mike Dudkowski, supported the request from Earnest Partners and confirmed there are no concerns with investing in the China Fund. The Investment Guidelines will need to be amended to allow investment in the China Fund as part of the portfolio.

MS. BARNEY made a motion, seconded by DR. BUCHER to approve Earnest Partners' to invest in the China A-Share Market through the Earnest Partner's China Fund subject to review and approval of the Subscription and Adoption Agreements and other relevant documents by legal counsel. The motion PASSED unanimously (10-0). (Motion #13-4)

#### 5. REPORT OF THE ADMINISTRATOR

Presentation by Administrator, Andrea L. Rose

- i. Administrator's Report dated January 22, 2013
  - a. Recommendation to Authorize Boomershine Consulting Group to Analyze the Cost Allocation by Plan and to Review the Basis for the Current Assumptions

Andrea Rose presented the Administrator's Report dated January 22, 2013.

The Participation Agreement with State Street Global Advisors (SSG) was executed in late December 2012. The ERS' transition manager, Global Transition Solutions (GTS) liquidated \$19.3 million in domestic fixed income securities from Pugh Capital Management to initially fund the new Public Real Assets fund with SSG. The transition was complete in January 2013. Mr. Dudkowski reviewed GTS' pre- and post-trade reports and noted the results with a total cost of \$4,108 or 2.1 basis points. GTS had a good strategy and favorable market environment which contributed to the good result. Subsequent purchases of approximately \$20 million and \$17 million were made from Rhumbline and Western TIPS, respectively.

The Agreement of Limited Partnership was executed with Wilshire Private Markets in early January 2013. The account will be funded over time via capital calls.

The ERS is awaiting revised language on the Investment Management Agreement for the Western Asset Global Multi-Sector Fund.

Ms. Rose reminded the Board that Boomershine Consulting Group (BCG) recommended two projects during the November actuarial valuation presentation. First, BCG recommended an analysis of the Cost Breakdown by Plan. BCG staff noted a skewing of the cost during the valuation project. Second, BCG proposed a review of the basis for the current set of actuarial assumptions. BCG provided a project plan letter dated January 24, 2013 which discussed the timing and fees for the cost breakdown by Plan and to review the basis for the current actuarial assumptions. The estimated fees for these projects do not exceed \$9,500.

MS. BARNEY made a motion, seconded by MS. WALSH to authorize Boomershine Consulting Group to analyze the Cost by Plan and to review the basis for the current actuarial assumptions. The motion PASSED unanimously (10-0). (Motion #13-4)

MS. BARNEY presented the regular report for the Investment Monitoring Group's (IMG) meeting of January 15, 2013.

At its November 6, 2012 meeting, the Board approved a motion to allow Earnest Partners to maintain securities, Hitachi, Ltd. and POSCO, until a policy is established that addresses securities that screen for involvement in the Sudan after the time of purchase.

The IMG discussed the fiduciary obligation to the participants in the plan and determined that Earnest Partners should not be forced to sell the securities (at a loss).

DR. BUCHER made a motion, seconded by MS. BARNEY to allow Earnest Partners to maintain securities at the current position, if the securities screen for involvement in the Sudan after the time of purchase. The motion PASSED unanimously (10-0). (Motion #13-5)

The IMG will return to the Board with revised Investment Manager Guidelines for Earnest Partners.

DR. BUCHER presented the regular report for the Administration & Personnel Oversight Committee meeting of January 15, 2013.

The ERS' current actuarial assumptions provide for administrative expenses equal to 1% of estimated covered payroll. The Board has used the 1% expense assumption as a guideline/restriction in preparation of the actual budget and has consistently maintained its budget within this amount. As the Commission's payroll has been reduced through management restructuring, the amount available for budget consideration using the 1% expense assumption has decreased making it difficult to effectively manage the ERS' increasing work program.

Staff researched other local public pension systems: Montgomery County, Prince George's County, WSSC, and Howard County. These retirement systems use the actual operating budget based exclusively on work program requirements with no restrictions based on payroll, assets, or liabilities.

The ERS' Actuary Dave Boomershine indicated that there has been a gradual change in the approach used for the actuarial expense assumption from a % of covered payroll to a 3-year (or 5-year) average of actual expenses. Mr. Boomershine is not aware of any retirement system that use either a 1% of covered payroll expense assumption or that allow the expense assumption to drive the operating budget.

Over the last couple of years, it has become increasingly difficult to work within the 1% expense assumption given the increased use of professional services (legal and tax) for alternative investments coupled with flat or declining payroll and increases in other budget areas. Fees related to alternative investments will continue to rise as the ERS must utilize outside legal and tax experts to assist in navigating this complex investment area. These fees are often difficult to estimate and flexibility in the budget is required.

The committee recommends the ERS' Operating Budget be determined each year based exclusively on the fiscal work program requirements with no restrictions based on payroll, assets, or liabilities and the actuarial expense assumption of 1% of estimated covered payroll be analyzed for appropriateness by the actuary.

DR. BUCHER made a motion, seconded by MS. BARNEY to approve the ERS' Operating Budget each year be based exclusively on the fiscal work program requirements with no restrictions based on payroll, assets, or liabilities and the actuarial expense assumption of 1% of estimated covered payroll be analyzed for appropriateness by the actuary. The motion PASSED unanimously (10-0). (Motion #13-6)

The committee reviewed a matrix prepared by staff showing how the ERS measures up against the National Conference on Public Employee Retirement Systems (NCPERS) Best Governance Practices for Public Retirement Systems. The committee determined the following actions were needed: 1) Update the Board of Trustees Reference Manual to include a summary of statutes and regulations, a mission statement, a list of all contracts and a reference to plan amendments and legal opinions maintained by staff. 2) Establish a formal privacy policy. 3) Research development of a risk policy. 4) Research how other agencies address risk and adopt a risk management framework. 5) Create a summary of all policy documents for easy reference.





SUBJECT: Health Care Reform Update

#### For Informational Purposes

On December 12, 2012, AON Hewitt Consulting presented an overview and update of the major provisions of health care reform to staff. The presentation focused primarily on the provisions that impact the Commission. The following is a summary, in chronological order of the provisions that have already taken place and provisions for beyond 2014.

#### 2012 and Prior:

- Adult children covered to age 26.
- No pre-existing condition exclusions for children under the age of 19.
- First dollar coverage of preventive health services (non-grandfathered plans only). Did not implement as the Commission's plans are grandfathered.
- Over the counter (OTC) drugs not reimbursable through FSA unless physician writes a prescription.
- Early retiree Reinsurance Program. The Commission received \$340,000.
- Issuance of Summary of Benefits and Coverage Notices.

2013:

- W-2 reporting of the full cost of employer sponsored medical and prescription coverage. Due January 31, 2013 for 2012 calendar year costs.
- Comparative effectiveness fee funds research. The research will evaluate and compare health outcomes and the clinical effectiveness, risks, and benefits of two or more medical treatments and/or services.
  - \$1 per covered life in the first year, \$2 per covered life thereafter.
  - o About \$5,800 for 2012 and \$11,600 for 2013.
  - First payment is due July 2013.
  - Costs were built into 2013 self-insured rates.
- Health FSA limit reduced from \$3,000 to \$2,500.

- Coverage of women's preventive health services (non-grandfathered plans). Did not implement as the Commission's plans are grandfathered.
- Increase in Medicare tax by 0.9% to 2.35% for individuals earning over \$200,000 and joint filers over \$250,000.
- New 3.8% tax on unearned income for individuals earning over \$200,000 and joint filers over \$250,000.
- Notify all employees about Exchanges, eligibility, services and contact information (Effective March 2013 no guidance yet).

#### 2014:

- Mandated Employer Coverage
  - Must offer coverage to at least 95% of all full-time employees or pay a penalty of \$2,000 per each full-time employee.
  - A full-time employee is anyone working an average of 30hrs per week, including seasonal employees.
  - Measurement or "look back" period to determine if employee averages 30hrs per week.
  - Stability period is the period of time coverage must be offered.
  - Some flexibility in measuring average hours worked and "look back" periods
  - Recent analysis indicates that seasonal employees working on average 30 hours or more make up 2% of all eligible employees; therefore we are not subject to the penalty.
  - Departments must be diligent in making sure seasonal employees do not work 30 or more hours per week, on average, over the course of the year.
- Free Rider Penalty
  - Employer will pay a penalty if an employee purchases coverage through an Exchange because:
    - Employer's plan was not "minimum essential coverage"
    - Plan was unaffordable (affordability threshold of 9.5% of adjusted gross income), or
    - Plan did not provide minimum value
    - The penalty is \$3,000 for each employee who:
      - Turns down employer coverage
        - Purchases a health plan in the Exchange, and
      - Receives a Federal subsidy
    - The Commission will have affordability issues for contract employees who contribute 70% of the premium.
- No pre-existing condition exclusion for anyone
- No annual dollar limit on essential health benefits. Commission plans are in compliance.
- State Exchanges open for small employers
- Auto-enrollment in a health plan for new and currently enrolled employees (deferred to 2015)
- Wellness Program Rewards Cap
- Individuals must maintain minimum essential coverage through employer or exchange, or pay a penalty based on taxable income

- State Temporary Reinsurance Program Contributions
  - Must make contributions to state temporary reinsurance programs that offset risk associated with high-cost Exchange enrollees.
  - Cost is \$63 per member per year, estimated to be about \$365,000 in 2014
  - o Amounts expected to reduce in 2015 and 2016

#### 2017 and 2018:

- Large employers may be allowed into Exchanges (2017)
- Excise tax on "Cadillac" plans (2018)
  - 40% excise tax for coverage costing more than \$10,200 individual, \$27,500 family (indexed)
  - Tax is applicable to medical and prescription coverage on the amount in excess of the cap





The Commission's procurement policy (Practice 4-10, Purchasing) includes an antidiscrimination component which assures that fair and equitable vendor opportunities are made available to minority, female or disabled owned firms (MFDs). This program is administered jointly by the Office of the Executive Director and the Purchasing Division and includes a price preference program and an MFD subcontracting component based on the Commission procurement practices and the available MFD vendors in the marketplace. The price preference program has been suspended until a MFD study is conducted to provide evidence that the price preference is/is not needed. This report is provided for your information and may be found on the Commission's intranet.

Some of the observations of this FY13 report include:

- Attachment A indicates that through the second quarter of FY13, the Commission procured approximately \$36.7 million in goods, professional services, construction and miscellaneous services. Approximately 25% or \$9.2 million was spent with minority, female and disabled (MFD) owned firms.
- Attachment B indicates that in the second quarter MFD utilization was 25.7%. The cumulative utilization through December 31, 2012 was 25.2%.
- Attachment C represents the MFD participation by type of procurement. The MFD participation for construction through the second quarter of FY13 was 38.8%. Attachment C also indicates that the largest consumers of goods and services in the Commission are the Prince George's County Department of Parks and Recreation and the Montgomery County Department of Parks. These programs significantly impact the Commission's utilization of MFD firms. The MFD cumulative utilization numbers for these departments through the second quarter are 31.9% and 18.0% respectively.
- Attachment D presents the FY13 activity for the Purchase Card program totaling approximately \$4.3 million of which 3.3 % or \$143,118 was spent with minority, female and disabled (MFD) firms. The amount of procurement card activity represents

cards are also used for training registration in order to guarantee attendance.

- Attachment E portrays the historic MFD participation rates, and the total procurement from FY 1991 to second quarter FY 2013.
- Attachments F shows the MFD participation in procurements at various bid levels to determine if MFD vendors are successful in obtaining opportunities in procurements that require informal bidding and formal bidding. Based on the department analyses, MFD vendors do appear to be participating, at an overall rate of 21.6% in informal (under \$30,000) and 27.6% in the formal (over \$30,000) procurements. In the newest delegation for transactions under \$10k, MFD participation is 20.4%.
- Attachment H presents the total amount of procurements and the number of vendors by location. Of the \$36.7 million in total procurement, \$26.7 million was procured from Maryland vendors. Of the \$9.2 million in procurement from MFD vendors, \$7.8 million was procured from MFD vendors located in Maryland.
- Attachment I compares the utilization of MFD vendors by the Commission with the availability of MFD vendors. The results show under-utilization in the following categories: African American, Asian and Females. The amount and percentage of procurement from MFD vendors is broken out by categories as defined by the Commission's Anti-Discrimination Policy. The availability percentages are taken from the most recent State of Maryland disparity study dated February 17, 2011.
- Attachments J and K are prepared by the Department of Human Resources and Management and show the amount and number of waivers of the procurement policy by department and by reason for waiver. Total waivers were approximately 1.7% of total procurement.
