ITEM 3 GENERAL ANNOUNCEMENTS

Chair Hewlett made the following announcements:

a) <u>Lesbian, Gay, Bisexual and Transgender Pride (LGBT) Month</u> – LGBT Pride Month is celebrated each year in June to commemorate the 1969 Stonewall riots in Manhattan. The month focuses on the positive stance against discrimination toward LGBT people, promotes self-affirmation, dignity and equality. This year marks the 50th anniversary of the LGBT Civil Rights Movement. Celebrations and memorials held during the month recognize the impact that LGBT individuals have had on history. The Diversity Council is sponsoring a panel discussion at the Montgomery

Regional Office on June 26th, from 1:00 p.m. – 3:00 p.m., whereby employees will share their experiences and the role that the Commission has played in their journey. This year's theme is: "Reflections of Pride – Stonewall 45". The panel discussion will be streamed as a webcast as well.

b) National Caribbean American Heritage Month – President Obama issued a proclamation recognizing June as Caribbean-American Heritage Month. The proclamation acknowledges enormous contributions that immigrants from the Caribbean have made throughout history. M-NCPPC celebrated Caribbean-American Heritage Month at Bladensburg Waterfront Park on Saturday, June 12^{th.} Over 1,000 people attended the event.

Significant June Events (not listed on the agenda)

Chair Hewlett shared the significance of Emancipation Day (June 19th), also known as Juneteenth. The Emancipation Proclamation was signed in 1862, and was effective January 1, 1863, to free the slaves. Many slaves could not read or write and did not know that they had been freed, particularly in Texas, where at least 250,000 slaves were not made aware of their freedom. The United States Government sent officials with armed troops to Texas with a directive to free the slaves. When the slaves were informed they had been freed two years prior, there was a huge celebration throughout Texas. This practice has continued to take place for 150 years starting in Texas. The M-NCPPC hosted a celebration this past weekend in commemoration of Juneteenth's 150th anniversary.

June also holds significance for other milestones such as: Flag Day, National Fruit and Veggie Month (June 15th is Eat Your Veggies Day), Professional Wellness Month, National Soul Food Month, African-American Music Month, Rebuild Your Life Month, and National Donut Day.

Chair Hewlett announced the reappointments of Casey Anderson as Chair of the Montgomery County Planning Board and Norman Dreyfuss as one of the Commissioners of the Montgomery County Planning Board. She congratulated them for their service.

Celebrations (not listed on the agenda)

Chair Hewlett extended birthday greetings to Prince George's County Parks and Recreation Director Ronnie Gathers in absentia and also to General Counsel Gardner. She wished a Happy Father's Day to all fathers and father figures.

c) Employees' Retirement System (ERS) Certificate of Achievement for Excellence in Financial Reporting, Government Finance Officers Association (A. Rose) Chair Hewlett commended the Employees' Retirement System (ERS) for receiving the Certificate of Achievement for Excellence in Financial Reporting for the 15th consecutive year.

d) Employees' Retirement System Award for Outstanding Achievement in Popular
 Annual Financial Reporting (A. Rose)
 Chair Hewlett extended congratulations to the ERS for winning this award for the 5th consecutive year.

Recognitions (not listed on the agenda)

Commissioner Geraldo shared that Chair Hewlett was awarded the James Taylor Award by the Prince George's County Bar Association for the great service she has rendered to the legal profession throughout the State of Maryland.

He also extended his appreciation to Prince George's County Parks and Recreation Deputy Director Debbie Tyner and the Prince George's County Parks and Recreation staff. He stated that the Fort Washington Potomac Overlook Young Men's Civic Association (YMCA) is closing at the end of June and that he contacted Deputy Director Tyner about the closing of this facility. Deputy Director Tyner spoke with the director of the YMCA about agency programs in the Fort Washington area because the closing of that YMCA location will leave a significant void in that community. Deputy Director Tyner presented Commissioner Geraldo with a copy of a book compiled by the Prince George's County Parks and Recreation staff that shares information about the community centers in Fort Washington. She will be presenting copies of this publication to the YMCA to distribute to its members. This one-time publication is entitled "The Fort Washington Area Community Centers."

Chair Hewlett extended kudos to the Prince George's County Department of Parks and Recreation for the wonderful Quinceañera celebration it hosted. Commissioner Fani-Gonzalez attended the celebration and was very impressed with the event.

e) 2014 Calendar JP Morgan Purchase Card Rebate Presentation (Zimmerman/Pearson) Secretary-Treasurer Zimmerman introduced Finance (Purchasing) team members: Principal Administrative Specialist Stephanie Akerley, Principal Administrative Specialist Mechelle Myers, Finance Manager Stacey Pearson, and J.P. Morgan Representative Robin Daley. Secretary-Treasurer Zimmerman explained that M-NCPPC has a Purchase Card program that is used for small purchases. The agency earned rebates from J.P. Morgan by running an efficient purchase card program, which is shared among M-NCPPC departments, pro-rata based. Secretary-Treasurer Zimmerman presented a rebate check to the Commissioners in the amount of \$203,260.29. Ms. Daley stated M-NCPPC started the program with J.P. Morgan in 2012. She noted that a 26% growth was reported last year. Currently, the agency is on track with 10% growth, which is very strong. She thanked M-NCPPC for the business and the partnership. The Commissioners congratulated the Finance team. The Finance team was photographed with Chair Hewlett and Vice-Chair Anderson.

ITEM 5 ACTION AND PRESENTATION ITEMS

a) Resolution #15-08 – Adoption of the FY 2016 Commission Operating Budget and FY 2016 Capital Budget (Barney/Kroll)

Corporate Budget Manager John Kroll presented a memorandum to the Commission requesting approval of the Resolution. As contained in the meeting packet, the Resolution adopts the budget for FY16 including the additions, deletions, increases and decreases from the submitted Proposed Budget as approved by the respective County Councils.

Executive Director Barney stated that Page 2 of Exhibit A (FY16 Adopted Budget – Montgomery County), which is attached to Resolution 15-08, was revised and distributed this morning. This page contained a minor correction to the Use of Fund Balance in the Park Fund on the Montgomery County side.

Mr. Kroll stated the bulk of the memorandum reflects changes from the proposed budget to the adopted budget. He stated that the FY16 budget is \$38.8 million lower as compared to the FY15 adopted budget. The Prince George's County budget is decreasing by 5.2% for FY16, while the Montgomery County budget is decreasing by 11% for FY16. With respect to the Prince George's County budget, due to the timing of the final fiscal rebalancing, most of the reductions have been placed in the non-departmental accounts of each fund. The specifics of the reductions and their effect on the departments' work programs for FY16 are being developed and will be presented to the Prince George's County Planning Board and the Commission in the near future.

Commissioner Geraldo inquired as to the meaning of ALA Debt. Corporate Budget Manager Kroll explained the acronym represents Advance Land Acquisition. M-NCPPC still has debt service outstanding in Montgomery County; however, the agency does not have any outstanding debt in Prince George's County. This allows the agency to purchase land for public purpose in advance of the need for such land, and allows the agency to purchase the land at a more reasonable cost and/or before it becomes unavailable.

Chair Hewlett and Vice-Chair Anderson commended Mr. Kroll for the work done on the agency's budget. Chair Hewlett thanked various departments, Prince George's County Parks and Recreation Deputy Director Conforti, and the budget team for working through the challenges this year.

Commissioner Presley noted that she was initially asked to participate in the

Chair Hewlett asked for clarification on the purpose of the meeting. She said

Vice-Chair Anderson shared that he is not in favor of the current logo because
it is not accomplishing the agency's intentions. He added that he does not
want the agency to go through endless cycles with this project making this an
infinite task. He expressed that Commissioner Presley would like to see the
Marketing/Branding effort completed during her term as Commissioner, which
ends in 2016. The group needs to determine the pathway to finalize this project.

Chair Hewlett stated she does do not share the same opinion as Vice-Chair Anderson on getting rid of the current logo. The logo is more identifiable with the public in Prince George's County because the agency carries out the recreation program in the county. She did agree that not everyone knows the magnitude of what the logo means; therefore, she is in support of modernizing it.

Commissioner Presley explained the purpose of branding is identification for customers and constituents, and what they see, feel, and associate. The purpose should quickly communicate a message to the people being engaged. If the brand does not mean what the agency is trying to communicate - which is that M-NCPPC is one agency and its offerings, such as parks and planning - then the emblem and the message are worthless.

Executive Director Barney stated the purpose of today's "check-in" was to explain where the agency is in the process, what has transpired up to this point, and to obtain direction from the Executive Committee. She explained that there has not been a consensus with regard to the logo or taglines that were recommended by the consultant LMD.

Commissioner Presley stated she was surprised that a decision was made to open the design effort to in-house staff. Her purpose at the meeting was to make a plea that the effort be restarted with a different kind of engagement and process. She stated that she was not happy with anything that the consultant presented.

Montgomery County Planning Director Gwen Wright stated that the Department Directors were not impressed with LMD's designs either. Because the Department Directors were not satisfied with the logos presented by LMD, Montgomery County Parks Director Mike Riley suggested inviting M-NCPPC's in-house graphic specialists, who are marketing professionals, to participate in the logo design process. The Department Directors agreed with the recommendation. Director Wright stated the agency's graphic designers came up with ideas, some of which the Department Directors liked. The selected concepts/logos were to be pushed back to the Marketing team and LMD to get their input and decide which could be fleshed out further with focus groups, if appropriate. Commissioner Presley stated there is no need to return to focus groups. Executive Director Barney responded that this is different than what was told to the Department Directors by the Marketing team.

Director Wright also noted that the Department Directors had some concern with proceeding with the Marketing/Branding effort at this time because of new information received about the budget, particularly on the Prince George's County side.

Vice Chair Anderson responded that there needs to better understanding of what the budget is to roll out this marketing plan. He added that if the cost is nominal, then that is the answer to give if questioned as to why this is occurring in the midst of a budget crisis; conversely, if the answer is it is not nominal, a plan needs to be made to get the process back on track, and perhaps roll out the branding effort the following year or year after. Vice-Chair

Anderson stated that soliciting ideas from staff sent a message that the branding project became an inward-facing exercise. The process should be more objective, data-driven and professionalized. He stated the purpose of the logo and branding exercise is the impact and the message the external audience receives or does not receive from the agency's communication efforts.

Chair Hewlett commented that the agency needs to understand the purpose of branding and what it is communicating externally. She stated that M-NCPPC's branding should communicate the core functions of the agency.

Vice-Chair Anderson stated that the problem with the logo is that the public associates the "shovel" or the Montgomery Parks/Montgomery Planning "tree" with the County; and that the message the logo conveys is inaccurate which is problematic for the agency. He suggested that before the Executive Committee meeting ends, everyone agree that this project not terminate because of short-term budget or lack of consensus concerns. He suggested someone under Commissioner Presley's direction write a memorandum explaining (1) the findings from the market research, (2) the purpose the agency hopes to achieve, (3) the objective of the exercise, and (4) the process moving forward. The purpose of the branding should be to achieve certain marketing objectives to external audiences, such as trying to remove the public misconception that M-NCPPC is a part of Montgomery or Prince George's County, and to emphasize that the agency governs parks and planning. Producing this memorandum will provide an understanding going forward, and will ensure that this process will not have to be repeated again in two years. The document should contain an explanation as to how the program can be rolled out, how much the project will cost, and what resources will be substituted and not added.

Executive Director Barney stated that the Department Directors are supportive of whatever the group decides to do about education, rollout, and communication.

Chair Hewlett and Commissioner Presley agreed that the messaging should be as uniform as possible. Chair Hewlett gave kudos to the internal graphic designers.

Commissioner Presley stated she would like to sanction Division Chief Williams to create a marketing plan to carry the agency through this project. Division Chief Williams is to outline where the agency is now and make her best marketing suggestion. The plan should include the Department Directors' highest level of concerns expressed, the proposed process, her opinion as to whether focus groups should be continued at the time of logo selection, and a schedule to roll out the plan. Vice-Chair Anderson requested the plan be oriented around June 15, 2016. Division Chief Williams agreed that Vice-Chair Anderson's request is reasonable.

Division Chief Williams shared that the LMD contract expires in two days which the Directors agreed to let expire.

Executive Director Barney thanked the Marketing team.

a) Departmental Sustainability Plans and accompanying PowerPoints (Nolan/E. Bennett/Mason)

Executive Director Barney asked Corporate Policy and Management Operations Division Chief Anju Bennett to speak to the Sustainability policy that was adopted by the Commission, and provide background on the reasons for the Departmental Plans. Division Chief Bennett explained that each Department generates a Sustainability Plan that explains how goals identified in Practice 6-40, M-NCPPC Sustainability Standards, are being implemented for its respective facilities, operations or services. These Plans are to be presented to the Executive Committee and updated at least every two years. Rather than doing seven separate departmental plans, the plans have been done on a regional basis by County, representing the location in which the department is located. Ms. Bennett also explained that the Practice called for an agency-wide sustainability committee which is charged with developing these Plans. The Executive Committee is responsible for approving the Plans.

Sustainability Co-chair Ellen Bennett and Sustainability Committee member Christine McGrew presented the Montgomery County Plan and Sustainability Chair Anthony Nolan presented the Prince George's County Plan, as contained in the meeting packet.

Mr. Nolan highlighted specific savings gained including \$1.1 million savings over 10 years, from light fixtures with high efficiency LED fixtures.

Both presentations identified that the agency is meeting or exceeding most standards in Practice 6-40. Specific costs and productivity savings accomplished by departments were highlighted in the plans. Mr. Nolan also identified specific savings related to productivity, such as significant savings in overtime/extra hours.

Vice-Chair Anderson asked if the Sustainability Committee has looked at parking at park facilities, as well as how to minimize impervious surfaces for parking lots. He stated M-NCPPC should reconsider use of surfaces and should consider shared parking with other private or public businesses. The Montgomery County Sustainability Committee members responded that the Montgomery County communication plan will be pivotal for this issue, as it can encourage the public to use public transportation options and address an increased use of carpooling. Co-chair Geoffrey Mason added that the storm water management program is addressing impervious surfaces.

The Executive Committee asked whether anyone has looked into capturing costs for recycled items. Secretary-Treasurer Joe Zimmerman responded that it is very difficult to make a profit from recycled resources. Vice-Chair Anderson requested that the Sustainability Committee quantify savings from the agency's efforts, and determine whether this effort is really fiscally prudent because M-NCPPC is a public sector entity, and does not enjoy benefits of tax incentives. He added that scenario needs to be factored into sustainability initiatives. Chair Hewlett commented that these presentations are very valuable in helping showcase the wonderful efforts within the agency.

ACTION: Motion of Hewlett to approve the Montgomery County and Prince George's County two-year Sustainability Plans Seconded by Anderson 3 approved the motion

At 11:37 a.m., the Executive Committee moved to closed session to discuss Benefit Plan Design Changes.

At 12:08 p.m., the Executive Committee reconvened to open session.

c) Briefing (Barney/Kroll) (taken out of order) Web Posting of Budget Detail Corporate Budget Manager John Kroll distributed a copy of the Budget Office's page of the budget, which is posted on the M-NCPPC website. He provided a brief explanation as to how to access and manipulate the document.

The meeting was called to order at 8:32 a.m.

Minutes from the December 17, 2014 meeting were motioned by Patti Barney to be approved, seconded by Commissioner Geraldo, and then unanimously accepted.

Following approval of the minutes, Mr. Bryant provided an overview of the economy and the markets in the fourth quarter as backdrop for the Fund's performance.

Mr. Bryant said the second estimate of GDP had come in at 2.2%, somewhat weaker than recent quarters, raising the possibility that the recovery was losing steam. He noted that this was the first estimate and that a second estimate and final estimate would be released in coming months. He said the domestic equity market increased 5% with a 10% increase in small cap stocks, the foreign equity market decreased 3%, domestic bonds increased about 2% and foreign bonds decreased about 3%.

This mix of returns was not favorable for the portfolio. Return for the quarter was -0.3%. The shadow index – an indicator of how the asset allocation performed – was up 0.9%, well behind the median return of 2.5%. The fund had greater than average exposure to emerging market equity which was the worst performing equity sector, while having no exposure to small cap domestic equity, which was the best. Manager performance also hurt. The Pimco All-Asset/All Authority fund registered a -4.2% decline against a hedge fund composite increase of 0.9% due primarily to its position in foreign stocks and bonds, and its short position in US equity. The Schwab fundamental index strategies also underperformed their indices, with the decline in the emerging market strategy being particularly severe. Mr. Bryant explained that these were due to the tendency of the strategies to take positions in equities with declining prices and the way that played out in oil and oil-related equities in the fourth quarter. Longer term he noted that the fund still had excellent returns, with a 14% annual return since the first quarter of 2009.

In discussing the fund going forward, Mr. Bryant noted that an asset allocation study would be presented in April. Commissioner Geraldo indicated that he wanted consideration given to minority owned firms, if they were qualified. Mr. Bryant indicated that he would attempt to provide appropriate choices to the commissioners with that in mind.

Patti Barney noted that the fund had never crafted an investment policy statement and asked Mr. Bryant to look at the IPS for the large fund and consider crafting an appropriate document for MNCPCC.

Patti Barney and Joseph Zimmerman questioned the cash flows being used for the asset allocation report. Mr. Bryant said he would set up a call between committee members and Luci Ryan, the person at Dahab responsible for creating cash flows for asset allocation studies.

The Committee approved a fee of \$18,500 for the Groom legal firm to review the real estate contract for Intercontinental, a private real estate fund recently approved by the committee.

Mr. Bryant noted that he had prepared a discussion of the various strategies employed by the Pimco All-Asset, All-Authority Fund, but there was not enough time prior to the Commission meeting to cover that topic. The Commissioners agreed to save that discussion for another meeting.

The meeting was adjourned at 9:34 am.

Resolution

WHEREAS. The Maryland-National Capital Park and Planning Commission ("Commission") is authorized under Maryland Annotated Code, Land Use Article §17-205, to sell, convey, transfer, lease or exchange any land held by it and deemed by the Commission not to be needed for park purposes or other authorized purposes; and

WHEREAS, the Commission owns certain property, known as Brandywine Road Park (R77), located in Brandywine, Maryland, having an address in the neighborhood of 1500 Brandywine Road, identified as Tax Map 156. Grids A-1 and B-2, Parcels 105, 7, and 93 and Election District 11, Tax Account Numbers 1151190, 1179092, and 1156223 at Liber 34369, folio 25; Liber 34369, folio 16; and Liber 34369, folio 05, containing 246.95 ± total acres, hereinafter collectively referred to as part of "Brandywine Road Park", and

WHEREAS. Mattawoman Energy. LLC has requested approval to enter into an option contract to convey a permanent easement extending approximately 1.2 miles $(6,300 \pm linear$ feet) and covering $1.9 \pm acres$ of Brandywine Road Park to facilitate the construction of a gas pipeline to serve their planned power generating facility in Brandywine, as well as an associated temporary construction easement over $8.1 \pm acres$ and,

WHEREAS, Mattawoman Energy, LLC has agreed to pay \$1,000 per year for an option agreement and requested that the option agreement can be extended for two one-year periods, if necessary, also for an additional payment of \$1,000 per each year.

WHEREAS. Mattawoman Energy, LLC has also requested that the Commission convey a permanent easement upon the provision of the compensation described below.

WHEREAS. Mattawoman Energy LLC has proferred to pay \$6,334.93 and convey title to two parcels of land, described as the Donald & Pamela Keith *et al.* property. Tax Account Number 1157908, Tax Map 155, Grid F-1, Parcel 21, 12.0 ± acres, and a parcel of Prince George's County surplus property described as Tax Account Number 1159896, Parcel 111, 3.91 ± acres, Tax Map 156, Grid B-2, as compensation for the conveyance of the permanent and temporary construction easements.

WHEREAS, upon receipt of the compensation described above, Mattawoman Energy, LLC has requested that the Commission convey the permanent and temporary construction easements described above to them.

WHEREAS, it has been agreed that if the easement is not utilized for the construction of a gas pipeline within five years of its conveyance to Mattawoman Energy, LLC, the easement will cease to exist.

NOW, THEREFORE, BE IT RESOLVED THAT the Prince George's County Planning Board at its meeting on Thursday, June 25, 2015, authorized the Executive Director to execute the option contract to convey a permanent and temporary construction easement. Additionally, upon receipt of the proferred compensation, the Executive Director is authorized to execute the permanent easement over $83,000 \pm \text{square feet or } 1.9 \pm \text{acres}$, along with a temporary construction easement of $352,000 \pm \text{square feet or } 8.1 \pm \text{acres}$, to Mattawoman Energy, LLC, all of which is subject to approval by the Full Commission. The Executive Director is hereby authorized to take any and all actions including signing any needed agreements, easements, option contracts, deeds and/or plats of dedication to convey a permanent easement from Brandywine Road Park to Mattawoman Energy, LLC.

Strategy for Building a Culture of Wellness

On May 11, 2015, Juanita Hawkins joined the Health and Benefits office as The Maryland-National Capital Park and Planning Commission's (M-NCPPC's) Wellness Coordinator. Juanita's primary responsibilities includes developing and implementing a comprehensive, data-driven wellness strategy for the Commission, including developing programs and strategies designed to promote a culture of health for our employees.

A health and wellness enthusiast, Juanita has over 10 years of experience in the HR field and most recently worked at Samueli Institute, a nonprofit research-oriented organization advancing the science of whole-person healing, as the HR Director where she implemented a comprehensive worksite wellness program. Juanita has a Bachelor's degree in Management from University Maryland University College; additionally, she is certified in worksite wellness, a certified Wellcoach, and an ACE certified Fitness Nutrition Specialist.

Juanita will provide a high level presentation on her framework for implementing a robust wellness program that will attempt to change M-NCPPC's culture to one of wellness.

A culture of health is defined by the CDC as the creation of a working environment where employee health and safety is valued, supported and promoted through workplace health programs, policies, benefits, and environmental supports. With our wellness program, our goal is to give our employees tools and resources to make smart, healthy decisions, which in turn adds value to the organization and increases employee engagement, attraction, and retention. Since poor well-being can reduce engagement and morale, increase the usage of contingent staff, increase turnover, etc., the availability of health and wellness programs at work can help employees feel more appreciated, engaged, more productive, and can lower the risk of work-related injuries.

Currently, we are utilizing random tactical programs for employee wellness. We are planning to move toward a more comprehensive holistic strategy, with a focus on prevention and behavior modification, increased linkage to benefit offerings, and measured outcomes. Some of the programs and activities we plan to implement in the near future include:

- Wellness challenges
- Promoting standing and walking meetings
- Healthy vending options
- Financial workshops
- Stairwell programs

Having a healthy work culture is vital to the success of worksite wellness programs. The emphasis will be on the creation of a culture and environment that supports health and wellness through various channels such as procedures, environmental support, reducing barriers, and support from organizational leaders.

Recognizing that health and wellness is personal, our programs will address a spectrum of needs from low-to-high risk employees. Additionally, this will be a collaborative effort as we will be partnering with other departments and staff to achieve our goals. Because leadership support is imperative to our success, we will engage leadership from the onset, to find out what's important to them and provide support to encourage them to participate in our programs and exhibit well-being. Likewise, we will have wellness champions at various locations that we will leverage to assist with marketing our programs, encourage employees to participate and provide input regarding the programs to offer to our staff.

Because addressing health and wellness from a holistic standpoint is critical, our framework will focus on five components as identified in "Well-being: The Five Essential Elements," by Tom Rath and Jim Harter. These areas include: career, social, financial, community, and physical. All of our programs and activities will fall into these categories so that we address a full range of employee needs. Our communication strategy will utilize newsletters, email, videos, and the development of an intranet site. The implementation process will include:

- **Assessments**: reviewing analytics from our healthcare providers, surveying staff, reviewing current policies and procedures
- **Planning**: identifying wellness champions, developing a logo, tagline, mission statement, and dedicating resources
- Program rollout: marketing education, awareness, communicating to staff
- Evaluation: tracking utilization rates, surveys, communicating results, etc.

Additionally, we will ensure that our programs are HIPPA and ACA compliant and we will utilize best practices from the CDC Worksite health Scorecard, HERO, and benchmarking with other similar organizations. We have a tremendous opportunity to change the culture at the Commission. I am excited to have this opportunity to help others improve their overall well-being, not just for the short-term, but to make a lifestyle change. I want to equip our staff with the skills and tools they need and surround them with a supportive environment that makes the healthy choice the easy choice. I appreciate the opportunity to present to you today.


