SUBJECT: Vacation Petition V-05005 Stonegate Estates, Plat One

Petition to Vacate part of Henson Valley Way, now known as Captain Wendell Pruit Way, as shown on a plat of subdivision, Stonegate Estates, Plat One, recorded among the Land Records of Prince George's County, Maryland, in Plat Book VJ 197, plat 20; being in the 12th Election District, and totaling 5,433 square feet or 0.1247 acre of land.

OVERVIEW

The subject property is zoned R-R and is located west of Temple Hill Road, in the northwest quadrant of the intersection of Stoneridge Court and Captain Wendell Pruitt Way (formerly known as Henson Valley Way) in Temple Hills. This portion of street has never been improved or otherwise used by the public. The Planning Board approved Preliminary Plan 4-03019 and DSP-04011 for Henson Valley Cluster for the property to the west of the subject site, which required the relocation of this section of Henson Valley Way. The realigned road avoids intrusions into environmentally sensitive areas that would have resulted with the previous road alignment.

The vacated area will be included in a new subdivision plat on the south side of Captain Wendell Pruitt Way, pursuant to preliminary plan 4-02053.

FINDINGS AND REASONS FOR STAFF RECOMMENDATION

- 1. The public utilities and Prince George's County have been notified of this petition as required by Section 24-112(e)(1) of the Subdivision Regulations.
